### Story

I was Supply Officer from February 1975 to April 1977. It was not a particularly good time for EDWARDS. We had a yard period at Pearl Harbor Naval Shipyard, and with a 1200-pound plant, came out with what seemed like more problems than we went in with. But, in any event, as part of the process of preparing for deployment was REFTRA, or refresher training....a series of exercises over several weeks, both in port and at sea to ensure the command could effectively fight and operate correctly.

One at sea period had us go through a few different combat scenarios. One was combat feeding. This meant getting food to the sailors at their battle stations, so the crew could maintain their stations. In order to do that, we had brought along sufficient Meals-Ready-to-Eat, sometimes referred to as "c-rats". They were in small cardboard boxes, with cans for main meals, cookies, and some fruit. Lots of calories, and some of the entrees were considered better than others.

Since this was a scheduled event, we were able to stage the MREs on the mess decks, and when the word was passed, "Commence battle feeding!", each battle station sent a representative to the messdecks, and collected the necessary number of boxes. Since my battle station was Gun Director #2, I relied upon the Chief Mess specialist to execute the plan.

I got my MRE in the Director, and was opening my meal when I got a call over my headphones: SUPPO REPORT TO THE BRIDGE. Aye, aye. I got out of the Director, made my way to the bridge, and the CO was holding a can of pork and beans that had expanded...the ends were rounded. He said: SUPPO, DOES THIS LOOK RIGHT? I said: No Sir, those cans means the contents are probably bad, and should be thrown away.

The next announcement over the 1MC was something like: IF YOU HAVE ANY MRE CANS THAT DON'T LOOK RIGHT, THROW IT AWAY! Almost simultaneously, several dozen small cans were flying off both sides, like miniature depth charges. But we passed the exercise, and never served MREs again.
